TERMS & CONDITIONS

LIFTS

All participants must have either a valid program card or current lift ticket displayed at all times. Verification may be conducted by Uplands staff at any time.

Lost program cards should be reported immediately to the upper clubhouse. Replacement cards will be issued only with proof of original purchase.

LESSONS

Uplands Golf & Ski Club does not offer make-up classes for lessons missed for personal reasons. It is recommended that, if a lesson is missed, the student practice on their own or take a private lesson (at their own cost) to ensure not to fall behind their class level.

All program participants (or, if under 18, a parent) are required to read, understand and sign a release before receiving their program rental card.

All program and rate categories are based on the age of the participant as of December 1st, proof of age may be required.

Uplands reserves the right to cancel any scheduled group of lessons due to insufficient registration. Participants already registered will be given the option of:

A) Transfer to another class of acceptable date and time, B) A refund of fees paid.

Under the rare circumstance that Uplands cancels a lessons, we will provide as much notice as possible. Registration forms will request a contact number to be used in these circumstances. Canceled lessons will be rescheduled within the season. Please check our website (GOLFNORTH.CA/UPLANDS) calendar for ALL cancellations and hours of operation.

Participants who have forgotten or lost their program cards must check in at the upper clubhouse prior to commencement of their class to obtain a temporary card or pass.

Program participants must arrive for their lesson at a minimum of 15 minutes before their scheduled class time. Late arrivals may be excluded from participating in the class.

If a participant is physically incapable of continuing within the program as supported by doctor's certificate, Uplands will provide a prorated credit to be applied towards future ski (or golf) activities.

Equipment must be returned to the rental office after each lesson. **Equipment returned late may be subject to a late charge of \$25 per hour or part thereof.**

All participants enrolled in an Uplands program must wear a recognized snow sport helmet.

REFUNDS

Refund requests must be received by Uplands a minimum of 14 days prior to start of the program. A \$35 administration fee will be retained. No refunds will be allowed after a program has begun. Transfers into another class will be permitted where possible, providing the request is submitted in writing. The administration fee may apply.

In this agreement the term "skiing" shall include "snowboarding".

ASSUMPTION OF RISKS

I am aware that skiing involves risks, dangers and hazards including but not limited to: boarding, riding and disembarking ski lifts; changing weather conditions; exposed rock, earth, ice and other natural objects; trees, tree wells, tree stumps, forest dead fall; the condition of snow or ice on or beneath the skiing surface; changes in variations to the skiing terrain which may create blind spots or areas of reduced visibility; changes or variations in the skiing surface or sub surface, including changes due to man-made or artificial snow; variable and difficult snow conditions; streams, creeks and exposed holes in the snow pack above streams or creeks; cliffs; crevasses; snowcat roads, roads or cut-banks; impact or collision with lift towers, fences, snowmaking equipment, snow grooming equipment, snowcats, snowmobiles or other vehicles, equipment or structures; impact or collision with other skiers; the failure to ski safely or within one's own ability or within designated areas; negligence of other skiers; and NEGLIGENCE ON THE PART OF Uplands Golf & Ski Club and GolfNorth Properties Inc. AND IT'S STAFF TO SAFEGUARD OR PRETECT ME FROM THE RISKS, DANGERS AND HAZARDS OF SKIING. I am also aware that the risks, dangers, and hazards referred to above exist throughout the ski area and many are unmarked. I freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting therefrom.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of Uplands Golf & Ski Club and GolfNorth Properties Inc. accepting my application for a group or private lessons and permitting my use of its lifts, runs and trails, snowboard and terrain parks, race courses and other facilities (hereinafter referred to as "the skiing facilities"), I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I may have or may in the future have against Uplands Golf & Ski Club and GolfNorth Properties Inc. and the directors, officers, agents, employees and representatives (all of whom are hereinafter collectively referred to as "THE RELEASEES") and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer as a result of my use or my presence of the skiing facilities due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE OWED UNDER THE OCCUPIER'S LIABILITY ACT R.S.O. 1990 C.O.2. ON THE PART OF THE RELEASEES, AND INCLUDING THE FAILURE ON THE PART OF UPLAND GOLF & SKI CLUB AND GOLFNORTH PROPERTIES INC. AND ITS STAFF TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARD OF SKIING. I AM ALSO AWARE THAT THE RISKS DANGERS AND HAZARDS REFERRED TO ABOVE EXISTS THROUGHOUT THE SKI AREA AND MANY ARE UNMARKED. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS, AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE AND LOSS RESULTING THEREFROM;
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from all liability for any damage to property of, personal injury to, any third party, resulting from my use of or presence on the skiing facilities;
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives, in the event of my death or incapacity;
4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of Ontario; and
5. Any litigation involving the parties to this Agreement shall be brought within the Province of Ontario.

In entering into this Agreement, I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSISTANTS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.

TERMS & CONDITIONS

Uplands programs consist of 7 weekly lessons and one bonus lift pass, that is to be used for either skiing or

snowboarding.

- The bonus lift ticket that is included with the 7-weekly lesson program, is valid from January 12th, to the end of the March 2021 winter season. Laminated tickets must be presented at the office or chalet check in, prior to entering the ski area. These passes are valid from the first week of lessons, until the end of the 2020/2021 winter season. These are non-transferable, non-refundable, and have no cash value. This bonus lift ticket does not include a lesson.

- All forms and waivers must be signed prior to the first lesson by a parent or guardian over the age (18+). Lift

passes/tickets must be visible to Uplands Golf & Ski Club Staff at all times on the customers.

- Programs are subject to date and time changes, depending on participation levels of the program.

- Lessons and programs WILL RUN IN ALL WEATHER CONDITIONS, unless a closure is announced within a 24- hour period prior, to unforeseen circumstances, such as a power outage, resulting in facility shut-down. An announcement will be posted on our website www.golfnorth.ca/uplands

- In the event of a closure or cancellation, lessons will be rescheduled.

- Refunds will not be issued for personal absences, unless a doctor's note is provided the Uplands Clubhouse.

- Please dress according to the weather conditions, appropriate for outdoors activities.

- Helmets are provided as part of the rental package; however, we DO NOT provide goggles or facial coverings as part of this package.

- CHILDREN UNDER THE AGE OF 7 MUST be accompanied by an adult (18+) or hired Apprentice for duration of the lesson. Adults must purchase the appropriate lift ticket to gain access to the hill and chairlift. Parent passes and season passes are available for purchase and are recommended if your child is in a 7-week program. Some exceptions may apply- if the child is the appropriate height and weight to safely raise and lower the bar UNASSISTED on the chairlift. It is the Instructor's discretion to determine if a child is physically able to continue to use the chairlift unaccompanied after the lesson has been completed.

- All program lift passes are valid for a three-hour period, and can be used either before lesson or after the lesson.

Without the appropriate lift pass or ticket, trespassers will be asked to leave the hill area.

- It is strictly prohibited for parents, guardians, and guests to enter the fenced off areas. This being any area that is designated as hill area that requires a lift ticket. All guests regardless of age or ability, must have a valid lift ticket purchased for the date and time they are to be on the hill.

- Cancellation of registration must be completed 14 days prior to the first day of the lesson, and made in person.

- All cancellations are subject to a \$35.00 + tax cancellation fee.

- All 7-week programs, private lessons, or hired apprentices are a NON-REFUNDABLE PURCHASES. Refunds are subject to a \$35.00 + tax cancellation fee per student. This will be issued in the form of a GolfNorth Gift Card, to be used at any GolfNorth Property. Cancellation of registrations must be made 14 days prior to the first day of the lesson, and must be done in person. Refunds will be returned onto the same payment method.

- Management reserves the right to make any changes to ALL resort operations, schedules, chairlift schedules,

terrain, runs, operating times, class times, prices, lessons, and programs.

- Any violation of the Alpine Responsibility Code, established by the Ontario Ski Resort Association (OSRA) will result in immediate removal from the hill, and be asked to leave Uplands Golf and Ski Club. This includes the removal of your lift ticket, a verbal notice of the violations reported, and a record of the incident that will be kept on file. Cases may be evaluated with the Uplands GM. Any minors under the age of 18 who have committed a violation, will be asked to remain with a member of the management staff until a parent or guardian is present to address the violations. All decisions are final to the order of the Uplands GM, and for a time period deemed appropriate for the offence committed.

REFUNDS

All Memberships are non-transferable and refunds are NOT available.
