HOW THE PAYMENT PLAN WORKS

This chart shows the default number of monthly payments that you can use to pay off your 2022 GolfNorth Membership based on when membership is purchased.

However, **any combination of payments are available so long as the minimum deposit of \$400+ HST is taken at time of membership sign up and the term does not exceed May 2022.**

Any remaining balance must be paid off in full by May 15th, 2022.

Monthly payments are processed on the 15th of every month or the next business day.

EXAMPLE:

Conestoga Multi-Course Membership Purchased in October
 2,295 + 13% Tax = \$2,593.35 - (\$400 Deposit + 13% Tax)
 = \$2,593.35 - 452
 = \$2,141.35 Remaining Balance ÷ 7 months
 = \$305.91 Monthly Payment

TERMS & CONDITIONS

All 2022 GolfNorth Memberships expire on October 31, 2022.

ADDITIONAL INFORMATION

Memberships are limited and sales may be discontinued at any time.

All members receive 15% off regularly priced Pro Shop merchandise, excluding balls and clubs. Members must present a GolfNorth Membership Card or photo identification before each round. Members are required to pay the appropriate associated fees when playing in any non-member events at any GolfNorth course. Additional fees may apply when participating in leagues or events at any GolfNorth course. Any fraudulent use of membership card will result in immediate termination of membership without refund and may be subject to criminal prosecution.

Weekday memberships are not valid on holidays.

Tee times must be booked under the appropriate member profile or the time will be subject to regular green fee rates.

JUNIOR & TEEN MEMBERSHIPS

Junior members must be born on or later than January 1st, 2010 in order to qualify for a 2022 junior membership. Teen members must be born between January 1st, 2004 and December 31st, 2009 in order to qualify for a 2022 teen membership.

Junior and Teen Memberships are valid after 11:00am on weekdays, and after 1:00pm on weekends & holidays.

All juniors and teens must be accompanied by an adult when playing during cart-mandatory times, or when playing at Mystic Golf Club and The Ridge at Manitou (unless they are 18 years of age and have a valid G2 driver's license). Identification must be provided to confirm age at the time of purchase. Junior and Teen member discount applies to the full posted rate when playing up - discount does not apply to the discounted junior rate.

INTERMEDIATE MEMBERSHIPS

Intermediate Members must be born between January 1st, 1992 and December 31st, 2003 in order to qualify for a 2022 intermediate membership. Intermediate Memberships are valid anytime on weekdays, and after 11:30am on weekends & holidays.

MISCONDUCT

Misconduct by any member will result in termination of membership without refund. "Misconduct" includes any type of abuse or harassment, verbal or otherwise, towards another golfer, guest or staff member.

PRICING

Applicable taxes not included on all prices. Prices are subject to change.

CLUB CHAMPIONSHIPS

Members are only permitted to play in the Club Championship at their home course. Home courses cannot be changed after purchase.

TRAFALGAR GOLF & COUNTRY CLUB MEMBERS

All Trafalgar Memberships of any kind include (subject to government restrictions) unlimited use of practice facilities, lockers, club storage, season pull cart use & GAO fees at Trafalgar Golf & Country Club only.

EARLY BIRDIE BONUS

Gift card amounts will be in the form of an electronic gift card that will be emailed to the member within five business days of activation of account. Gift card bonus available until December 10, 2021.

Gift card amounts are equal to 10% (pre-tax) of the membership purchase and excludes Junior and Teen Memberships, membership add-ons, cart packages, and range programs.

Gift Cards may be used towards GolfNorth purchases at all Ontario golf courses, including green fees, cart rentals, food & beverage purchases, and pro shop merchandise. Gift cards are not valid for membership related purchases, programs, yearly rental fees, league fees, or member event fees.

Early Birdie Gift cards will not be amended or increased after December 10th with the purchase of an upgraded membership. Should a member not have an email address, the gift amount will be placed on account.

CART DISCOUNT PROGRAM & SEASONAL CART PROGRAM ADD ON DISCLAIMER

The price paid for the Cart Discount Program & Seasonal Cart Program, as applicable, covers yourself for cart use as a single rider. If your group includes two golfers with cart privileges, you must ride together (unless government regulations specify otherwise). Cart Discount Program & Seasonal Cart Program are both non-transferable.

You must notify the pro shop of any person or person's equipment riding with you during a round. Those not obeying this rule will lose their Cart Discount Program & Seasonal Cart Program privileges without refund. The price paid covers you for the 2022 golf season, from course opening to October 31, 2022 inclusive. Cart privileges do not extend beyond October 31st. You may use a golf cart for as many rounds as you like during the season, but you will not receive a refund if you have failed to fully utilize your Cart Discount Program or Seasonal Cart Program.

The season cart pass does not entitle you to use a cart for practice sessions or spectator purposes. You acknowledge that there are certain risks of physical injury and agree to assume all risk of injury with respect to injury to persons or property which you, or any other person operating the golf cart rented under this agreement, may sustain or cause. You agree to reimburse GolfNorth for all charges resulting from damages to the cart or other property caused by the golf cart rented under this agreement, except for ordinary wear and tear to the golf cart itself. Such reimbursements shall be paid on the credit card account that you have provided to GolfNorth.

You hereby irrevocably authorize GolfNorth to charge your credit card an amount that GolfNorth believes is sufficient to repair all such damages. You understand and acknowledge that a person must be 18 years of age or older with a valid driver's license to operate a golf cart.

REFUNDS

All membership and add-on sales are final. Memberships are non-transferable and refunds are not available. In the event of a shortened season due to government regulations or weather, there will be no credits or refunds.

Please read and initial the following to confirm your understanding of the 2022 GolfNorth Payment Plan program.

Participants in the Payment Plan program must make an **initial payment of \$400+ HST** upon registration.

Payment plan is **ELIGIBLE for Early Birdie Gift Card in May**, only once full payment has been made.

Monthly **payments come out on the 15th** of each month or the next business day. **Payments can only be made with VISA or Mastercard.**

It is the responsibility of the member to provide GolfNorth Properties with updated credit card information. Member is responsible for any costs or fees that may be incurred by GolfNorth for outdated information. Delinquent payments will result in suspension of membership until account is brought current.
