4. Limited to 1 round per day and Corporate Cards must be presented at time of check in. No exceptions. Corporate Members shall be responsible for any rounds booked and/or used above 1 round per day, and GolfNorth shall invoice for such rounds at full market rate.
5. Must be a registered operating company to qualify for any corporate package.
6. All membership and add-on sales are final. Memberships are non-transferable and refunds are not available. In the event of a shortened season due to government regulations or weather, there will be no credits or refunds.
7. There is a \$100 fee for replacement of lost or stolen cards.
8. Courses subject to change without notice.
9. The price paid for the Seasonal Cart Program, as applicable, covers yourself for cart use as a single rider. If your group includes two golfers with cart privileges, you must ride together. A maximum of two carts are permitted in any group.
